### MANUFACTURER'S LIMITED WARRANTY

QMC Cranes, LLC. makes no warranty, express or implied on any product manufactured or sold by QMC Cranes, LLC. except for the following limited warranty against defects in material and workmanship on products manufactured by QMC Cranes, LLC.

QMC Cranes, LLC. warrants the products manufactured by QMC Cranes, LLC. to be free from defects in material and workmanship under normal use and service for a period of twelve (12) months from the date of shipment. This limited warranty does not extend to any product of another manufacturer or to any part, component, accessory, or attachment not manufactured by QMC Cranes, LLC. The warranty, if any, with respect to any product of another manufacturer or to any part, component, accessory, or attachment not manufactured by QMC Cranes, LLC. is limited to the warranty, if any, extended to QMC Cranes, LLC. by the Manufacturer of the other product part, component, accessory, or attachment.

This limited warranty does not extend to any product (or any part or parts of any product) which has been subject to improper use of the application, misuse, abuse, operation beyond its rated capacity, repair, or maintenance except in accordance with the sales and service manuals and special instructions of QMC Cranes, LLC, or modification without the prior written authorization of QMC Cranes, LLC. (Whether by the substitution or non-approved parts or otherwise.)

The sole obligation and liability of QMC Cranes, LLC. under this limited warranty (and the exclusive remedy for any purchaser, owner, or user of QMC Cranes, LLC. products) is limited to the repair or replacement, at the option of QMC Cranes, LLC. of any production (or any part or parts of any product) manufactured by QMC Cranes, LLC., which, within the warranty period, shall have been returned to the QMC Cranes, LLC. facility in Sparks, Nevada (or any other location within the United States as shall be designated by QMC Cranes, LLC.), at no expense to QMC Cranes, LLC. and demonstrated to the satisfaction of QMC Cranes, LLC. as being defective in material or workmanship.

To make a claim under this limited warranty, contact QMC Cranes, LLC. or QMC Cranes, LLC. authorized dealer or distributor from whom the product was originally purchased. A statement giving the model and the serial number of the allegedly defective product, the date and description of the alleged defect, the date of the purchase, and proof of the purchase date must accompany the return product (or any part or parts of any product). Any product (or any parts or parts of any product) determined by QMC Cranes, LLC. to be defective will be repaired or replaced, at the discretion of QMC Cranes, LLC., free of charge, FOB Sparks, Nevada. No credit will be given for any allegedly defective product (or any part or parts of any product) not returned to QMC Cranes, LLC.

There are no other warranties, express or implied, in addition to this limited warranty. This limited warranty is exclusive and in lieu of all other warranties, express or implied (in fact of by operation law or otherwise), including the implied warranties of merchantability and fitness for a particular purpose.
